TRANSFORM LIVES, IMPROVE ECONOMIC GROWTH

Introduction – skills development programme

With 65% of India's youth in the working age group, there was an increasing need to address the lack of skills development for economic growth - of the individual and the country. Recognizing this gap, SledgeHammer Foundation decided to put together a vocational training programme that can provide skills to youth, provide job placements and foster individual career growth.

During our field research, we come across several young girls who had dropped out of school for various reasons. These girls were seeking employment but lacked skills. The seed for the SledgeHammer Foundation skills development programme was sown. We founded the programme in 2015. We will begin with beautician and tailoring courses and the girls will be placed either in beauty parlours or other jobs.

How will we conduct the skills development programme?

We are aligning our programme to the larger goals of the foundation:

- We will ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.
- We will provide affordable and quality technical, vocational and tertiary education, including university, by 2030. We will create the right strategy.



- Our goal is to substantially increase the number of youth and adults who have relevant skills, including technical and professional skills, for employment, decent jobs and entrepreneurship. We will form partnerships and collaborations to do so.
- We aim to eliminate gender disparities in education and ensure equal access to all levels of education and vocational training for the vulnerable, people with disabilities, indigenous people and children who live in unsafe situations.

Our strategy

We will align and expand our courses as per the schemes of Ministry of Skill Development and Entrepreneurship. The government of India has come up with several plans, grants and resources to bring up the employability in the youth and we at SledgeHammer will continually work to imply the same in our skill development centre.

We aim to reach out to more than a 100 youth this year. In order to reach out to young girls to join the beautician course, we put out advertisements. We also collaborated with local beauticians to conduct classes and courses with the girls.

Our belief and motivation

The success of a nation always depends on the success of its youth and we at SledgeHammer Foundation want to guarantee, through our work, to bring advantages and opportunities for these young Indians. The time is not far when India will evolve into a skilled society where there are prosperity and dignity for all.



eddeHammer Found

Learning center- Neev TRANSFORMATION – ONE BY ONE

We started the Learning Centre in 2015. It was the keen interest of Mrs Pratima Mohanty, wife of the Managing Director, Pradeep Mohanty, to support underprivileged children with basic education.

The core objective of the Learning Centre

- Provide primary education enabling children to read and write
- Prepare them for the mainstream school
- Assist in admissions for mainstream school
- Ensure holistic growth and education
- Follow NCERT syllabus
- Timely follow up and feedback
- Regular parent-teacher meetings
- · Constant supervision to maintain the punctuality and attendance
- Guidance, personal talks, discussions to keep a check on drop out the number

Our aim and how we plan to achieve success

We have founded the learning centre to prepare children to get enrolled in the primary stream school. We are aiming to support children as young as four years old to as old as sixteen years. In the first year this programme saw some children who just started their education while few other who had left in between and now will now restart with our efforts, as well as those who have are in the teens but never went to any school.

To initiate the programme we will reach out through the mediums of advertisement in newspapers, pamphlets, and hoardings and by conducting talks in the slum areas.

Overcoming key challenges

There are a lot of children who belong to families of the migrant population in search of better work opportunities. The parents work at the construction sites, have tea stalls, are rickshaw drivers or house servants. This results in a higher school drop out number. This is also the reason why children don't want to get enrolled in mainstream school. To overcome this issue, we will have to encourage and guide children to enrol in the open school examination. This is one of the key challenges of this programme.

Key highlights of the year

In the first year of its inception, with just four children and by the end of 2016 the centre was beaming with 100 children.

We have decided to support the children who get enrolled in the mainstream school with 50% fees.

As a foundation, we recognize the importance of each and every aspect of society. For the same, the foundation will initiate small projects and programmes in collaboration with other entities or individually. Some of the initiatives that we are putting together are:

Swacch Bharat Mission – Contributing to a clean country

Low hygiene and cleanliness standards have been a serious issue in India.

"A clean India would be the best tribute India could pay to Mahatma Gandhi on his 150 birth anniversary in 2019," said Shri Narendra Modi as he launched the Swachh Bharat Mission at Rajpath in New Delhi.

On 2nd October 2014, Swachh Bharat Mission was launched throughout the length and breadth of the country as a national movement. The campaign aims to achieve the vision of a 'Clean India' by 2nd October 2019.

Following the guidelines of Swaach Bharat Mission, SledgeHammer Foundation will be actively involved in the following activities:

- Install dustbins all across Faridabad region
- Organize garbage collection vans all over the city
- Conduct timely cleanliness drives and involve various organizations and schools into it to create awareness as well as to make the city cleaner and hygienic.
- Carry out regular mosquito fogging.

SledgeHammer Cricket Academy was the brainchild of Mr Pradeep Mohanty, Managing Director – SledgeHammer. Aligned to his aspirations, the academy was set up in 2012, to make a focal point of cricketing greatness, both in education and training. The academy and foundation activities related to cricket were already set in place since the inception of the academy. We later registered the foundation and included the cricket programme in the foundation.

Overview

Overview

SledgeHammer Foundation has been set up as a public charitable trust established under the Indian trust Act, 1882 on 05th January, 2015 at New Delhi.

The Trust is represented by Sledgehammer Oil Tools Pvt. Ltd. as the Settlor and Mr. Pradeep Mohanty, Mrs. Rittu Mohanty, Mr. Krishan Chandra Mohanty, Mr. Ankur Kaushik, Mr. Dinesh Agarwal as Trustees. The sole object of foundation is to provide charitable services in the fields of primary health, education, skill development & Improving and empowering the lives of socially under privileged, including development of livelihoods.



Overview

SIGNIFICANT ACCOUNTING POLICIES

1. Basis of preparation of financial statement:

The accompanying financial statements have been prepared in accordance with the generally accepted accounting principles in India (Indian GAAP) issued by Institute of Chartered Accountants of India ("ICAI") The financial statements have been prepared on an accrual basis and under the historical cost convention.

2. Use of estimates:

The preparation of financial statements in conformity with Indian GAAP requires estimates and assumptions that affect the reported amounts of grants/donations, expenses, assets and liabilities and the disclosure of contingent liabilities, at the end of the reporting period. Although these estimates are based on the management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future periods.

3. Revenue recognition:

Grants/donations are recognized on cash basis. Interest Income is recognized on accrual basis.

4. Fixed Assets:

Fixed Assets are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any. The cost comprises purchase price, borrowing costs if capitalization criteria are met, directly attributable cost of bringing the asset to its working condition for the intended use and initial estimate of decommissioning, restoring and similar liabilities. Any trade discounts and rebates are deducted in arriving at the purchase price.

5. Depreciation:

The trust provides depreciation on fixed assets at the rates and in the manner specified in the Income Tax Act, 1961.

6. Prior period items:

Prior period items, if any, are included in the respective income and expenses and material items are disclosed by way of note.

7. Provisions, contingent liabilities and contingent assets

A provision is recognized when the company has a present obligation as a result of past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Contingent liability is disclosed for (I) possible obligation which will be confirmed only by future events not wholly with in the control of the Trust or (ii) present obligation arising from past events where it is not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount of the obligation cannot be made. Contingent assets are not recognized in the financial statements since this may result in the recognition of income that may never be realized.
